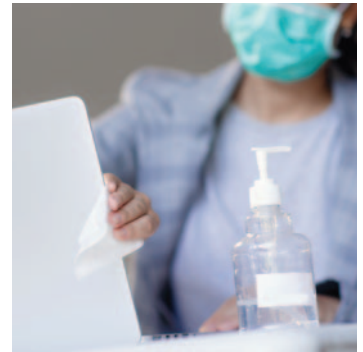

President Ruth McCoy appointed Sandra Horner, Sara Hager and Cynthia Jones as the nominating committee. Two director seats are open. Board members and volunteers are not compensated for their participation on the Board.

The nominating committee has placed the following incumbents as candidates for the 2 open Board positions for a 3-year term:

Donna Warren and Margie Coan

Nominations for the Board of Directors open positions may also be made by petition in accordance with our by-law Article V, In-Person Election; Nominating Committee and Nominations by Petition, Section 1 "the election will not be conducted by mail ballot and there will be no nominations from the floor" Members who wish to use the "nomination by petition" process may obtain a petition packet from the nominating committee at the credit union office.

***Petition Packets will be available August 31, 2020 and should be returned or
post marked by the end of business on October 2, 2020.***

In accordance with our by-laws Parliamentary Procedures will apply, whereby the nominee's will be determined by plurality vote and will be by ballot except where there is only one nominee for each position to be filled.

ADDRESS CHANGE – If you change your address you must notify the credit union in writing or in person. When writing, be sure to include your account number and a signature for verification. Remember notifying the post office will only temporarily forward your mail. If you are changing your name you must bring all updated identification into the credit union or mail notarized documents so that we may update our records.

INACTIVE/ DORMANT ACCOUNT FEE – All accounts with no activity for 12 months will be considered inactive or dormant. The credit union will assess a fee of \$ 2 per month to any share/savings or share draft/checking account that hasn't had a deposit or withdrawal for one year. Account balances under \$50.00 will be closed if inactive for more than one year.
